ORDER:

In the reference 1st read above, Government have constituted Ananthapuram-Hindupur Urban Development Authority (AHUDA) with Headquarters at Ananthapuram with an extent of 3120.05 Sq.Kms stretching from Ananthapuram Municipal Corporation, Hindupur and Dharmavaram Municipality with jurisdiction covering 180 villages in 18 Mandals.

2. In the reference 2nd read above, the Hon'ble Chief Whip, Andhra Pradesh Legislative Council as requested to including Uravakonda Constituency i.e., Kuderu, Uravakonda, Vajarkarur, Vidapanakal and Beluguppa Mandals in the AHUDA region for planned urban growth and prosperity of Uravakonda Constituency as the Uravakonda Constituency is well connected to district Headquarters Ananthapuram.

3. In the reference 4th read above, the Vice-Chairman, AHUDA, Ananthapuram has furnished the details with regard to name of the villages, population and the total extent of Villages of five (5) mandals of Uravakonda Constituency proposed to be included in AHUDA along with relevant maps to the Government, for taking further necessary action.

Government after careful examination of the matter hereby include Uravakonda Constituency with five (5) Mandals i.e., Kuderu, Vajrakarur, Beluguppa, Uravakonda and Vidapanakal along with the villages in the said Mandals with a total extent of 1900.44 Sq.Km in Ananthapuram-Hindupur Urban Development Authority.

5. The Vice Chairman, Anantapuramu - Hindupur Urban Development Authority (AHUDA), Ananthapuram shall take further necessary action, accordingly.
